Crescendo! Studios and Voice Talent Casting will not submit third party billings unless to a previously approved account and with prior approval of our Credit Manager.

Invoices will be submitted within 10 days of completion of the project. Please do not make any deductions from invoices or statements. All approved credits will be applied to your account by our Credit Manager.

Our billing is an open invoice system. All individual invoices charged to your account will continue to appear on your statement until they are cleared by a payment or credit. Invoices that are underpaid will continue to appear on your statement.

For prompt credit to your account please indicate on your check the invoices being paid.

Accounts that have charges that are 60 days or more past due may be placed on a COD status. The COD status may be cleared by our Credit Manager upon satisfactory settlement of the account. Accounts that are repeatedly placed on a COD status may be closed permanently.

All charges on your account constitute a lien on any master tapes or other materials produced or in our possession and these items may be held until all charges are paid.
